The FPO are issued in accordance with the terms of the *'Share Sale Deed relating to the shares in the capital of Agility Applications Pty Ltd'* (**Deed**) between HUB24 Limited, the shareholders of Agility Applications Pty Ltd (the **Vendors**) and others on 28 November 2016.

Under the terms of the Deed, (i) on completion of the Deed, HUB24 will issue FPO to the Vendors equal to AUD\$4,000,000 at an issue price of \$5.41, and (ii) following completion of the Deed but subject to the satisfaction of certain performance targets (as set out in the Deed), HUB24 will issue FPO to the Vendors at an issue price determined by taking the value weighted average price of HUB24's share price in the 20 days prior to the relevant performance target date.


