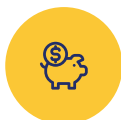

Custody services

HUB24 Custodial Services Ltd provides the custody services for HUB24 Invest and HUB24 Super. We outsource custody to professional third-party sub-custodians who are recognised leaders in the services they offer. As a provider of custodial services, we are regulated by ASIC and are licensed under our AFSL 239 122.

Assets in your account are held on trust for you – you are the beneficial owner of your assets.

The legal interest in your assets is held by the appointed sub-custodians.

Your assets are not part of the HUB24 Group's assets or the sub-custodian's assets.

Cybersecurity

Keeping your assets safe and secure is important to us. That's why we've integrated multi-factor authentication so you can add an extra layer of security to your HUB24 account. Opting in can help protect you and your assets against cyber threats. In fact, according to Microsoft, it can prevent up to 99% of credential theft.³

Your assets are also protected against fraud through:

Tight controls around systems where your data and funds are held.

Staff screening process prior to investor interactions and gaining access to required systems.

System access limited to key staff, under a supervised environment, with periodic reviews.

Mandatory written request from you for any material changes to your data.

Several controls in place to ensure the validity of request.

Segregation across key administrative functions.

Annual independent external auditor checks.

Regular reconciliations.

In an event of system breakdowns or online viruses, HUB24 has several measures in place to protect you and your assets:

Firewalls, spyware, and anti-virus software monitored and maintained by our IT team.

Robust and tested disaster recovery plan.

Backup of data multiple times daily prior to critical tasks.

24-hour monitoring of IT hardware.
