### **Applying for a Director ID, Corporate Trustee**

### In this fact sheet, we will cover some helpful tips on applying for a Director ID.

### Why do I need a Director ID?

When establishing a Corporate trustee for your SMSF, a Director(s) must be appointed. Under the Corporations Act 2001 (Cth) (Corporations Act), an eligible officer (Director in this case) must apply for a Director ID prior to their appointment.

Once all Directors have obtained a myGovID, all Directors must apply for their Director's ID via the Australian Business Registry Services (ABRS). Once <u>each Director</u> has completed this step, the Director ID must be provided to your adviser.

*NB:* Before you apply for your Director ID – you will need to have your myGovID, please refer to the HUB24 SMSF Access Fact Sheet – myGovID.

### Applying for a Director ID:

### Gathering the required documentation to apply for your Director ID

Once you have your 'myGovID', further personal information is required to complete your Director ID application. Collecting this prior to commencing the Director ID application will streamline the process.

From the ABRS website, depending on your myGovID identity strength, you will require the following documentation:

If you have a myGovID with a Standard identity strength, you need to provide:


- your individual Tax File Number (TFN) optional but it will help speed up the process
- your residential address as held by the ATO
- information from 2 of the following documents to verify your identity, including:
  - bank account details the ATO has on record most likely where you've received a tax return refund in the last 2 years
  - an ATO notice of assessment
  - Australian Prudential Regulation Authority (APRA) super fund account details including super fund's Australian business number (ABN). Note: Self-managed super fund details are not accepted
  - o a dividend statement
  - a Centrelink payment summary
  - $\circ$  a PAYG payment summary this is different to your income statement or your PAYG

Preferred - If you have a myGovID with a Strong identity strength, you only need to provide one of the following:

- your individual tax file number (TFN)
- your residential address as held by the ATO.

### To complete your application, please follow the steps below (The ABRS recommend that you use Google Chrome or Firefox web browser to complete your online application.)

1. Navigate to https://www.abrs.gov.au/ and log in to ABRS online with your newly established myGovID.



2. When you log in, a 4-digit code will display on your browser. You must open the myGovID app separately and enter in the code (this is a 2-factor authentication process).

3. Once logged in, apply for your director ID by clicking "Apply for a director ID":



Once you receive your Director ID, the Director ID MUST be shared with your Adviser so the ID can be included on your SMSF Access application. A Director ID must be completed for all Directors.
